1. Access the portal

You can access the EMEA Grants Portal by:

- Using the link: https://webportalapp.com/sp/login/gore_emea
- Connecting to the Gore website: <https://www.goremedical.com/eu/grants>

2. Create an account

The first time you connect to the EMEA Grants Portal, you will need to set-up an Account. To do so, you will be requested to provide an email address and password.

Sign In/Sign Up Instructions

For New Users:
By clicking **Sign Up**, you will be prompted to enter your email address and create a password. Once you have chosen your password, your account will be created and you will gain access to the portal.

For Returning Users:
Sign into the portal using the email address and the password you created when you originally signed up for the portal. If you have forgotten your password, click "**Forgot your password?**" and follow the prompts to reset your password.



You will only need to register the first time you log in. Once you have registered the first time, you will be able to log in by providing your email and password.



3. Create a profile

Once you have registered, you will be requested to create a "Profile"



To successfully complete your profile, please complete all fields. Mandatory fields are marked with an * Asterisk.

Please make sure to select the correct type of organisation:

For the type of organisation marked with an asterisk, you will be prompted to upload documentation on the legal set-up.

Once you have completed all the mandatory fields, you will be able to save your profile.

You are now ready to submit grant requests on behalf of your organisation.



4. Homepage & Dashboard

- You will be able to edit/update your profile anytime.
- You can change the language on the portal into German, French, Italian or Spanish by clicking on the globe icon on the upper-right corner (next to your user profile email address).
- You will be able to view and track all your grant requests. The status of each request will be displayed as follows:
 - Action required (marked BLUE)
 - o The request was started but not yet submitted.
 - o The request has been returned to you for more information.
 - Under review (marked GREY)
 - o There is no action required from you unless indicated differently by the Gore Grants Office via e-mail.
 - o The request is under review and/or in progress by the Grants Office/Committee.
 - Closed (marked GREY)
 - o No further steps are required.
 - o The application was rejected. You have been previously notified by e-mail.

For subsequent requests, click +Add Another
Grey = application under review or closed
Blue = action required

5. Create a grant request

- To submit a grant request on behalf of your organisation, click "+ Add Another"
- You will be prompted with 4 sections for completion:

1	General Information Please complete this section with the general information for your request.	Action Required	Open
2	Congress Attendance Please complete this section if you are requesting funding to support HCP participation to a congress – Not applicable for PCOs. If you wish to apply for grant funding for more congresses, please click "+ New Item".	Optional	Open
3	Departmental Event / Course Please complete this section if you are requesting funding to support the organisation of an event or course – Not applicable for PCOs. If you wish to apply for grant funding for more events/courses, please click "+ New Item".	Optional	Open
4	Declaration Please complete this section in lieu of a signature.	Action Required	Open

- Section 1 and 4 are mandatory sections. You will not be able to submit before completion of these two sections.
 - Section 2 and 3 are only required if you selected this option on the "General information form (1)".
- Once you have completed all applicable sections, the "Submit" button on the upper side will turn green.
 - You can save a draft and submit at a later stage.
 - If the "Submit" button does not turn green, check the forms for any missing information / attachments.
 - Once you have submitted your request, the system will notify the Gore Grant Office and the review process will start. You will receive status updates and/or e-mail notifications with additional updates or actions needed.

6. Professional Congress Organisers

If you are applying as a Professional Congress Organiser, we will request different information from you. This is clearly outlined on the submission portal. You will not be required to complete sections 2 and 3 mentioned under Chapter "5. Create a grant request".
